This policy outlines how magazine "Plant Protection" ("Fitomedika N EOOD") processes personal data in accordance with Regulation (EU) 2016/679 (GDPR) and the Bulgarian Personal Data Protection Act (PDPA).

1. Controller

2. Legal Basis & General Processing

We process personal data only to the extent necessary to provide a functional website, content, and services.

- **EU Regulation:** Art. 6(1) GDPR serves as the primary legal basis.
- **Bulgarian Legislation:** Processing is conducted in compliance with the **Personal Data Protection Act (PDPA)**, specifically regarding local derogations (e.g., age of digital consent).
- **Security:** We use SSL/TLS encryption for all data transmission.
- **Hosting:** Hosted by **Exoscale/A1** in **EU**. *Legal Basis: Art. 6(1)(f) GDPR (Legitimate Interest).*

3. Data Collection on This Website

A. Server Log Files

Technical data is automatically collected for security and stability purposes:

- Browser/OS, Referrer URL, IP address, Time of request.
- **Legal Basis:** Art. 6(1)(f) GDPR.
- **Retention:** Deleted automatically after **90 days**.

B. Contact Form / Email

Data provided by you (Name, Email, Message) is stored for communication.

- **Legal Basis:** Art. 6(1)(b) GDPR (Contractual) or Art. 6(1)(a) GDPR (Consent).
- **Retention:** Deleted upon resolution of the inquiry, barring statutory retention periods.

C. Cookies

- **Technical Cookies:** Essential for function. *Legal Basis: Art. 6(1)(f) GDPR.*
- **Third-Party Cookies:** Only with explicit consent. *Legal Basis: Art. 6(1)(a) GDPR.*

4. Third-Party Services

- **Google Analytics:** Uses IP anonymization. Data may transfer to the USA under the EU-US Data Privacy Framework. *Legal Basis: Consent (Art. 6(1)(a) GDPR).*

5. Your Rights

Under GDPR and the Bulgarian PDPA, you have the right to:

- **Access, Rectification, Erasure** (Art. 15-17 GDPR).
- **Restriction of Processing** (Art. 18 GDPR).

- **Data Portability** (Art. 20 GDPR).
- **Object to processing** (Art. 21 GDPR).
- **Withdraw Consent** at any time.
